  - i. Nuventive Improve Susan
    - i. Training complete; 164 participants; 97% positive response
    - ii. Training video will be available in June
  - ii. Ongoing surveys Kelva (2019 SSS Preliminary Report)
    - i. Student Satisfaction Survey; overall response rate 36.5% (increase from last year)
    - OSU PD Survey closed April 29; 7,000 total responses (students, staff, faculty); Chief Jones and Captain Chandler pleased with response rate and quality of feedback; working on final report for OSU Police Department
    - iii. Campus Climate Survey for Students (General Education/Diversity survey); closing May 6; 2,271 responses; reporting for survey will begin in summer
    - iv. Alumni Survey; one month left for responses (2,500 responses so far)
    - v. Parent/Guardian Survey; waiting for Provost approval of headlines
