Executive Summary

The 2005 OSU Survey of Alumni of Graduate Programs was conducted to identify institutional strengths and areas for improvement as indicated by recent graduates, to track the career and continuing education trends of recent graduates, to assess achievement of learning outcomes as perceived by alumni from individual academic programs, and to accomplish the State Regent's mandate for assessing student and alumni satisfaction. The survey was conducted in February 2005 and targeted alumni of graduate programs who graduated in calendar years 1999 and 2003. The survey was administered as a telephone interview and included Common Questions (related to employment and continuing education) and questions related to program outcomes for each degree program.

- *Response Rate.* A total of 787 telephone interviews with alumni were completed, resulting in a response rate of 36.0%. When adjusted for alumni for whom a telephone number could not be determined and alumni who could not be reached in the U.S., the response rate to the survey was 68.7%.
- *Residency.* Over 64% of the alumni who participated in the survey were living in Oklahoma, and almost 36% were contacted out-of-state. Because the survey did not attempt to reach alumni who were not in the U.S., the number of alumni who no longer live in Oklahoma may be underestimated.
- *Employment.* Over 90% of alumni reported that they were employed. Most alumni reported working for educational institutions (40.1%) or large corporations (26.9%). Almost 16% were employed by small businesses or corporations, and 10.9% were employed by government agencies. Alumni most frequently reported that their annual salary was in the range of \$36,000-45,000 per year (19.3%). Almost 94% of employed alumni reported that their OSU education had prepared them very well or adequately for their current position.
- *Continuing Education.* Almost 17% of alumni had completed or were currently enrolled in graduate programs or professional schools. Almost 61% were enrolled or had attended OSU graduate programs. Almost 61% percent were pursuing or had completed doctoral degrees, 21.1% were pursuing or had completed masters degrees, 6.8% were pursuing or had completed business degrees, and 3.0% were pursuing or had completed law degrees. Almost 94% of alumni that went on to graduate or professional school stated that their OSU education had prepared them very well or adequately for their continued education.

Methods

Population. The target population for this survey was OSU graduate degree recipients who graduated in **1999** and **2003**. Alumni response rates for individual programs are listed in Table 1. This included all departments in the Colleges of Agricultural Sciences and Natural Resources, Arts and Sciences, Spears School of Business, Engineering, Architecture, and Technology, Education, Human Environmental Sciences, and almost all programs in the Graduate College.

The total number of alumni in the target population was 2,187, which represented 98.9% of the total number of graduate degrees granted in 1999 and 2003. The survey was conducted in February 2005; therefore, alumni were contacted approximately one and five years after graduating from OSU.

Instrument Design. The Assessment Council and the individual academic departments that participated in the survey developed the survey instrument. The first part of the survey, called the Common Questions, was given to all alumni. It included questions on current employment, continuing education, and overall satisfaction. The second part of the survey was developed by each participating academic unit and was only given to alumni of that unit. This part of the survey focused on specific aspects of the alumnus' degree program.

Survey Administration. The survey was administered as a telephone interview. The OSU Bureau for Social Research conducted the survey interviews in February 2005 and coordinated data collection. The OSU Office of Institutional Research, the OSU Foundation, and individual academic departments provided alumni telephone numbers. The Office of University Assessment and Testing coordinated the development of the survey instruments, efforts to obtain accurate alumni telephone numbers, data analysis, and report preparation.

Results

Response Rate. A total of 787 alumni telephone interviews were completed, resulting in an overall response rate of 36.0% (Table 1). Out of the initial target population of 2,187 alumni, 1,042 alumni could not be reached because either there was no phone number available or the number was deemed 'unreachable' (e.g., wrong number, disconnected). After accounting for 'unreachable' alumni, the overall adjusted response rate was 68.7% (Table 1).

Out of the total population of survey respondents, 17.8% were alumni of the College of Arts & Sciences, 18.9% from the Spears School of Business, 8.6% from the College of Agricultural Sciences and Natural Resources, 16.0% from the College of Engineering, Architecture and Technology, 4.3% from the College of Human Environmental Sciences, 29.4% were from the College of Education, and 5.0% were from the Graduate College.

Current Employment Information. Over 90% of alumni (n=715) reported that they were employed (Q1). Of these, 90.5% were employed full-time (Q4). Approximately 40.1 % were employed by educational institutions; 26.9% of alumni described their employer as large corporations; 15.7% were employed by small corporations or small businesses; 10.9% were employed by government agencies; 3.8% were employed by nonprofit organizations and 2.4 % were self-employed (Q3). Table 2 summarizes the names of alumni employers and job titles. The most frequently reported annual salary range for alumni one and five years post-graduation was more than \$36,000 but less than \$45,000 per year (19.3%). Over 63% of alumni reported annual salaries of greater than \$45,000 per year, and 17.1% of alumni reported annual salaries of less than \$36,000 per year (Q7). In general, 93.8% of alumni (n=623) responded that their graduate program prepared them very well or adequately for their current position (Q6). Only respondents who reported that their current position was slightly, moderately, or highly related to their degree program were included in this calculation.

Graduate/Professional School Information. Of the alumni surveyed, 133 (16.9%) had completed or were currently enrolled in a graduate or professional school. Of these alumni, 60.9% were pursuing or had completed doctoral degrees, 21.1% were pursuing or had completed a masters degree, 6.8% were pursuing or had completed business degrees, 3.0% were pursuing or had completed law degrees, and 8.3% were pursuing or had completed 'other' degrees (Q9). Of the 133 alumni who were attending or had completed graduate school, almost 61% (n=81) attended Oklahoma State University, and 10.5% attended graduate school at other Oklahoma institutions. Most

alumni (93.9%) stated that their OSU graduate program had prepared them very well or adequately for additional graduate or professional school programs (Q10). Table 3 summarizes the names of graduate and professional schools as given by alumni.

Resident Information (in-State / Out-of-State). Over 64% of the alumni who participated in the survey were living in Oklahoma and nearly 36% were out-of-state (Table 4). Because the survey did not attempt to reach alumni who were not in the U.S., the alumni who live outside of Oklahoma may be under-represented.

This report summarizes data from the Common Questions that were given to all alumni. Alumni were also given a set of questions that were developed by the academic program from which they received their degree. Results of program-specific survey questions are summarized in separate reports prepared for each participating academic unit.
